Write-in Candidates: An eligible elector who desires to be a write-in candidate¹ will for the board election must file an affidavit of intent stating that he or she desires the office and is qualified to assume his/her duties if elected. The affidavit must be submitted to the DEO **no later than Monday February 27, 2023 at 5:00pm**.

Self-nomination forms submitted to the District are public records (1-4-504 CRS).

¹ Write-in candidates' names are not listed on the election ballot but a blank line for each write-in candidate is provided on the ballot to allow voters to write the name(s) of the write-in candidates on the line(s) and cast their votes for those candidates.
